Section 3 - Hazards Identification

*** Emergency Overview ***: Contents Under Pressure. Harmful if inhaled. May affect the brain or nervous system causing dizziness, headache or nausea. Vapors may cause flash fire or explosion. Extremely flammable liquid and vapor. Harmful if swallowed.

Effects Of Overexposure - Eye Contact: Causes eye irritation.

Section 6 - Accidental Release Measures

Steps To Be Taken If Material Is Released Or Spilled: Remove all sources of ignition, ventilate area and remove with inert absorbent and non-sparking tools. Contain spilled liquid with sand or earth. Section 7 - Handling And Storage
